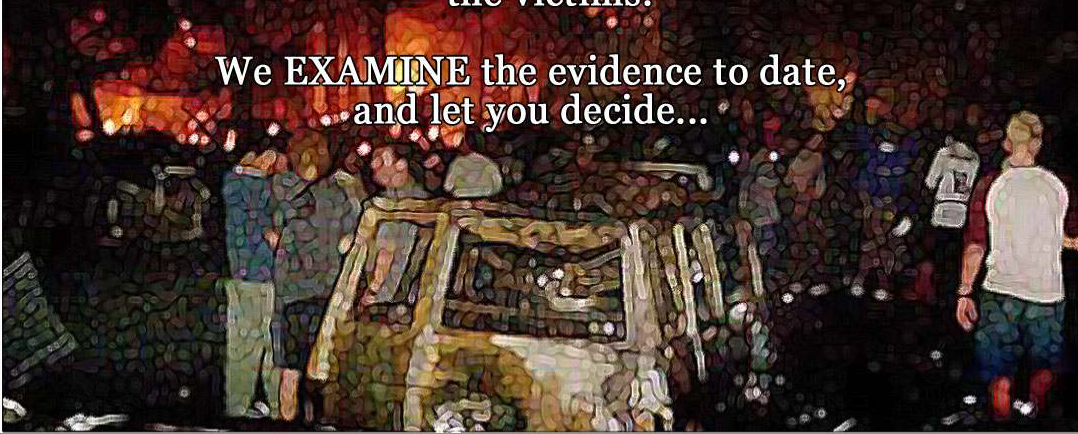

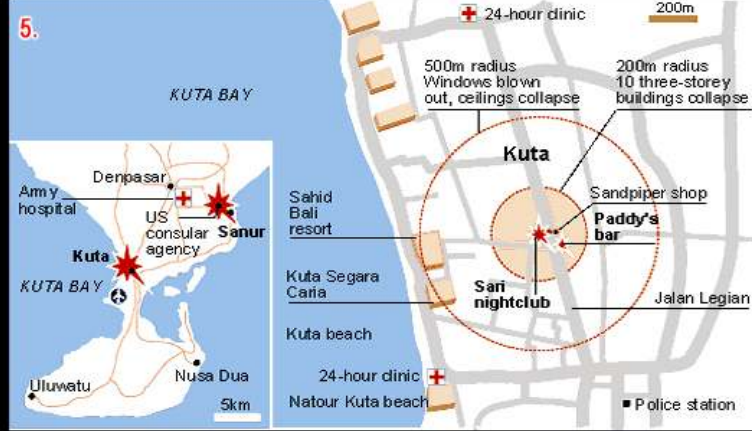

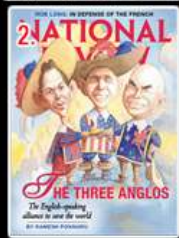

The Bali events actually benefitted a few key select groups that actually gained an advantage, lets take a look at the Whos Hows and Whys.



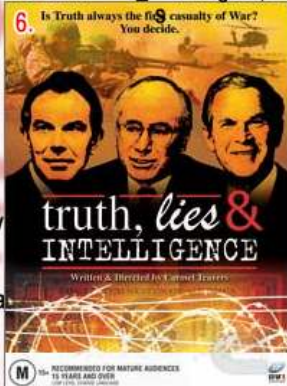

*13 September 2000 A car bomb explodes inside the garage of the Jakarta Stock Exchange building, killing 15 people. *2.

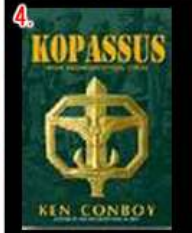
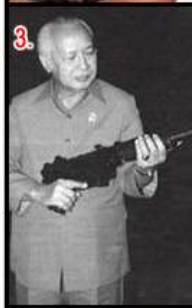
**26 Sept 2000 Police arrest 2 Kopassus (special forces) soldiers for recent string of bombings.

**25 December 2000 - Bombs explode at 11 churches across the country, killing 19.

In 1998 after the fall of the brutal Suharto regime, the Indonesians were "pressured" by IMF and World Bank to swing "more democratically" and abandon the blatant military intimidation of its citizens. Unable to practice the corruption that was now the Police domain, the Kopassus needed to remind their Govt. that a strong Military was needed. It was finally revealed on Sept. 26th 2000 by then new Police Chief General Suroyo Bimantoro said the two soldiers detained "were the ones who planted the (stock market) bomb. He said one was a member of the elite Kopassus special forces unit. "They also pitched in with making the bomb. We have proof for that," he added.



Kopassus effectively acted as former President Suharto's private army during his rule and the latest arrests are likely to heighten suspicions that elements in the army carried out the bombing in protest at the former president's recent legal trial on serious corruption charges. Within Indonesia therein lies a great potential for a home-grown military threat.





1. As it turned out, the rogue elements within Indonesian military and linked to Suhartos Kopassus had much more carnage and bloodshed planned at Western targets. General Bimantoro said the pair had been detained in the Javanese city of Bandung on Sunday following the arrest of 25 suspects in Jakarta a day earlier. One of the suspects had even admitted their next targets were to include the United States embassy and a Jakarta department store.



2. Given that remarkable fact, and the fact that on the night of the Bali bombings the US embassy in Bali WAS attacked. I'd say chances that Indonesian military were involved are remarkably high.



Earlier in Sept 2000 then President Wahid ordered the arrest of Mr Suharto's youngest son Hutomo 'Tommy' Mandala Putra in relation to the bombing campaign, but he was released after Police said there was no evidence of his involvement. Tommies father the ex- despot ruler was charged with stealing at least \$583m in government money during his 32year rule.



3. Incredibly, Aubdurrahman Wahid pointed out to SBS film crews in October 2005 that it was indeed more likely Indonesian Police or Military officers may have played a central key role in the 2002 Bali bombing, rather than Jamaa Islamiya!! "Here in America, we are living in the eye of a storm," he said. "All around us, dangerous winds are swirling and these winds could reach our shores at any moment."

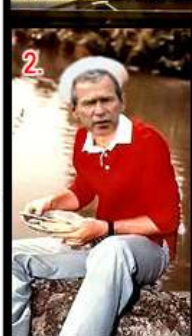
Sounds like the guy knows something is going down to me.

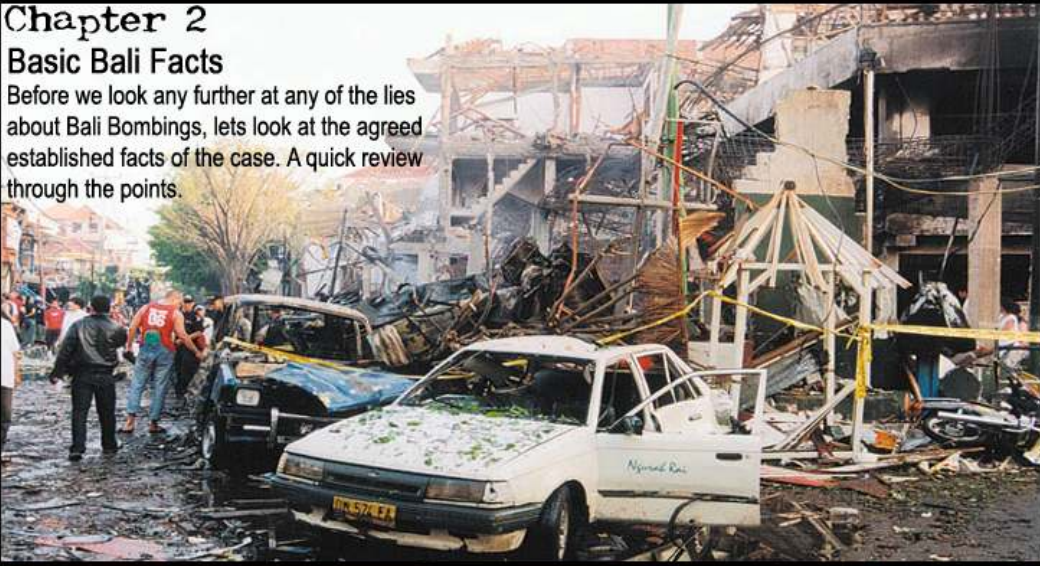

Telling it how it is....

With eye witness accounts of this nature, although the individual may be recalling a moment of shock and panic, even when the thoughts and recollections are not clear, and even when the details are seemingly non-relevant, they are still regardless pieces of evidence, and still held as essential when getting a clear picture of what occurred at the Bali Bombings Ground Zero site.

One person who was very together during the events was Juli Santoso, she was sitting talking with her Danish boyfriend in a Balinese bungalow that night, not far from Sari Club Kuta area as she recalls: " We decided not to go out like we often do every Saturday night because we feel tired after a long meeting. We arrive home around 10:30pm. We were sitting in our terrace in our bungalow about 600 metres from the location of the bombing. We were just sitting and talking there.



Suddenly, the house really started shaking and I was afraid, wondering what's going on noisy, that sound from the glass behind me, and the sound of the bomb explosions was really scary (I knew this after someone told me that there was a bomb explosion). At the time, I said to my boyfriend it must be an earthquake because a couple of nights before also the same but without that big sound of explosion.

I saw our neighbour standing outside and pointing their finger to the sky behind our building, so I decided to walk out and follow her point and I call my boyfriend to go outside and show him that big giant mushroom from the smoke, and not a long time after we see the red sky under that. We were thinking it must be a fire from a gas explosion.

We were waiting for some of the people who take care of our bungalow area to decide to go there and check it because the fire looked bigger. We were waiting with a really bad feeling because it will blow the fire to our bungalows.

Ten minutes after, someone come and he said to me it was a bomb because he met a western tourist who was running with bleeding on his body who said: 'There's a bomb in this town, you better go from this city, don't go there'...."

Or this one from Anna Nishida in W.A. who was visiting Bali from living in japan for some time: " Each evening since Saturday October 6, I sat on our terrace in my sarong with my book and bourbon, hoping to enjoy the fresh evening air and greet people as they came and went from the hotel. It was just after 11pm when I suddenly felt restless, not knowing what to do with myself. I went inside my room, where my husband had fallen asleep and my brother-in-law was still reading. For some strange reason, he asked me to come inside and read my book instead, strange I thought at the time but I obeyed.





It had been about three minutes after locking the door when there was this terrific bang and the whole room shook.

"...Smoke arising..

Then there was another one, even louder and stronger. At first, I thought it to be an earthquake. Living in Japan, this is something one is used to. But after the second bang, it sounded like 100 rats racing all over the place.



The sound seemed to get louder and quieter and it was all over the place. About five seconds after the second bang, we heard the shattering of glass.



I knew it was an explosion of some kind and perhaps the kitchen in our hotel. I went out to the front of the hotel, found nobody but when I looked up to the sky, I found it to be a bright red ball with pure white smoke arising from it in mushroom form.



I and the other few hotel guests stared at the red ball and thought it to be an airplane crash until we realised the smoke was white and not black



We decided after a while to go down to find out what was going on. It became more and more frightening as we made our way through the crowds coming towards us from the scene. Nobody would answer us as to what happened, most of them were moving aimlessly and looked to be in shock. As we approached the fire, we found a couple of western men and

women coming out of the dark, covered in blood..

These accounts as horrific as they truly are, are a necessary step to fully understanding what occurred.

Incredibly, there were AFL footballers from the Melbourne Demons were walking along Jalan Legian in Kuta that particular night. Danny Corcoran the club mgr, said: "A huge explosion blew them off their feet." Thankfully none of the 20 players were injured.

Further testimony shows clearly what people had seen and the grisly sights encountered at Bali Ground Zero.

"Sari's went up in a millisecond," said Simon Quayle. "I can't believe I'm alive. Eight of our boys are missing."

Blair Robertson, 23, of Port Fairy VIC. said: "There was a massive explosion ... from the front of the club. It was the biggest bang you can handle... I was facing the front of the nightclub," he says. "I saw all the television screens around the bar explode. I saw heaps of people burning and dying around me...."

It was an inferno. I saw one guy whose leg had been blown open . . . he couldn't walk . . . he was just lying there screaming. I saw another man with severe facial burns. It was hard to tell if he was dead or alive. There was so much screaming."

This next account from British tourist in Bali; Matt Noyce is particularly interesting:

"...Basically there was just a massive explosion. You didn't really realise it was an explosion to start with. You just saw a blinding light and your ears felt like they were exploding. Outside it was awful, like something you'd see out of Vietnam. There were bodies everywhere.

There was just complete panic in the bar, loads of people diving for the door trying to scramble over each other.

Then outside it was awful, like something you'd see out of Vietnam. There were bodies everywhere.

It was pretty dark but you could tell some people were really badly injured. Lots of blood everywhere, people with burns. Some people with limbs that just, well, just terrible, terrible injuries ... it was awful, the streets were really clogged with people, those people who had made it out of the bar and people who were wounded. It was quite a while before any kind of help came.

Fires started to spring up after the explosion and I saw one fire engine arrive quite a bit later. People who were walking were trying to help those people who were on the road or unconscious or couldn't move or get them onto the pavement.

The whole place was in chaos because it was a really busy Saturday night. So it was a horrible sight.

In the end, a few of us were trying to take the worst wounded and get them away

from the scene because some of the fires were getting pretty hot.

These people were pretty badly injured, you wouldn't really want to move them normally but there was no other help. I was afraid there were going to be more explosions and more fires springing up because we didn't know whether it was a bomb or a gas cylinder.... Some people said they thought it was a gas cylinder. You couldn't really see you couldn't tell who was the worst injured, it was just chaos, it was horrible. But one person I was talking to who was a fireman, an American or a Canadian, said he could smell TNT in the air. He said he was sure it was an explosion..."

One Bali Muslim elder, Haji Prianto, initially thought a plane had crashed, the noise and trembles knocking down items in his house almost a kilometre south of the blast. "I went outside immediately and looked to the airport area. I thought it was a large aircraft that had either not taken off or landed properly. But I could see nothing . . . Then I stared north to Legian, and that is when I saw this very large ball of fire and a cloud with a grey-orange colour 100 metres high." Mr Haji thought he could help, and grabbed

a torch, a first-aid kit, and a two-way radio and made for the blast site on his push bike.





1. Chris Filmer: "There was this huge bang followed by the hotel shaking, like a semi-trailer had collided with the hotel.. ..all the service doors in the corridor had been blown open open and there was dust on the floor. We were on the fourth (top) floor and someone said they could see flames. We went down the corridor and you could see over to the Poppies Lane area and you could see a huge fire which was spreading rapidly..."

A French photographer, Cyril Terrien, said: he had "never seen such an appalling thing. There are charred and mangled bodies everywhere, it is unbelievable," he told the BBC.

3. Fiona Lewis of WA: "No one got out the front of either club," said Ms Lewis. "We ran down to help, but there were so many people in the street, burned, injured or dead. One woman had lost the whole bottom half of her body. A man was crawling up the lane. He had no feet." Survivor Simon Quayle was quoted on ABC radio: "It was like a bloody war movie..."



4. One bloke ... looked like a bit of wood, that's how burnt he was. A few of us helped this German lady out. She had no clothes on ... maybe it was burning and she ripped them off. You just think about it and you break into tears." Nicole McLean, VIC, was close to the first explosion in Paddys Bar. When she awoke from the initial blast, she saw her right arm dangling from her shoulder, and dropping off to the floor. "I picked it up and said 'I m taking this baby home!' And I grabbed it and I said 'They re gonna sew

this sucker back on.' And I was keeping it. Then once I got there (to the hospital), I just knew that it wasn't ... wasn't going to be right ..."

Inside a nearby Hotel Marion Houghton, 43, and her sister, Gail McCarthy, (NSW) tended to the burned victims. "They were in agony. We got mattresses and wrapped them in wet sheets and blankets. The burns were so bad we were afraid to touch them. There were two Australians ... both in dreadful condition"

Johan Dukar ran to the Sari club after the 1st blast to find his brother, a door person at the Sari Club. "The second bomb exploded right in front of me. I was still conscious when I hit the road, but I soon realised I could not walk anywhere because my legs were broken. ...I still have a lot of shrapnel inside of me, in my chest and in my head. I also have bits in my private parts. In the middle of my chest, they found a screw and a bolt. In my legs, there is still glass. I lost my beloved brother in the bomb. He was blown to smithereens. I only received him back in pieces, in envelopes."

Scott Smithwick was in a nearby club and recalls the moment: "...The night was going well until the first small boom was heard and three seconds after, the next massive explosion was heard and felt and everyone absolutely shit themselves when the power went down.

The floor shook, glass shattered, the sound of screams all of which were in total darkness except for a huge fireball which was leaping into the sky.

The power came back on and then the flood of people came running down the street screaming and tipping water all over each other...."

Skin was peeling off (them) and a lot of other things that I wish never to think of or remember again. The smell, the look of fear, the rush of adrenalin and worst of all, the fear of being in a foreign country and not knowing where to help people, where to take them. Panic and confusion



reigned supreme for hours.

The bastard that let that bomb off was probably sitting 200 metres away laughing and patting himself on the back for a job well done."

Sari Club survivors Amanda Fisher and Peta Trinder recall the horror surrounding them, after making out of the inferno:

"There was a girl. Blonde. She was just covered in blood," says Trinder.

"A couple of people were carrying a security guard from the Sari Club. From head to toe (he) was just covered in blood. His body was exposed. You could see his insides," says Fisher.

The two Melbourne women walked through a growing crowd of onlookers. Fisher recalls: "They were lining the path. They made a path for you to walk through and their jaws (were) dropping, just looking at you, thinking, 'What has happened to these people?' Their eyes were popping out of their heads. They couldn't believe what had happened."

Bruce Baker, from the Gold Coast, was another who rushed to the scene with his 15-year-old son to help. "We got as close as we could, we got right there, (but) you couldn't go any closer because of the flames," he later recalled. "Some poor bugger was lying right on the corner and one of his legs was gone ... he was quite coherent. He was just saying, 'Shit, shit, shit, what's going to happen to me?' I said to him, 'You'll be right, mate, someone will come'."

NSW State Wide Severe Burns Unit chairman and Concord Hospital burn injury unit director Peter Haertsch said he had never seen civilian casualties like those he had operated on in the previous 24 hours. "I've seen plenty of burns but I've not seen this combination of injury, it's something you wouldn't see in civilian life and it's something I haven't seen in 22 years of burns surgery." Doctor Fiona Wood of the Royal Perth Hospital burns unit said that the debris, dirt and sheer velocity associated with the blast had combined to create the "worst burns she had ever seen." She said, "I've been training for 20 years for this. I've practised for it, but I never expected it."





1. Captain Rodney Cocks: (Aust Army on leave from East Timor in Bali. Co-incidentally who has done specialist explosives training.) "I got about 30 meters down the street and then I heard one blast and I thought, 'What was that?'"



2. Then the power cut...all the power went out. I didn't think bomb. I didn't think anything at that stage.



3. And then, probably, I'd say two seconds later, there was just the huge flash, and I was just covered in glass, put on the ground, and it just started...it was like hell on earth. I've done demolitions courses with the Army and it was bigger than anything I've ever blown up in my time, and I've done a bit."

He said of the morgue: "The bodies were just...the floor was littered with burnt corpses. it was just awful...some of these bodies you couldn't tell, you know, whether they were male or female, young, old, Indonesian, Australian..."

Corporal Cocks said of the crater at the scene of the Ground Zero blast, next morning: "You need a lot of bang to get through and make that sort of hole. That second bomb was huge."

(This is from an explosives trained military Corporal.)

Here are some anonymous first hand eye witness accounts:

> "I saw heaps of people burning and dying around me. It was an inferno. I saw one guy whose leg had been blown open - he couldn't walk - he was just lying there screaming. I saw another man with severe facial burns.

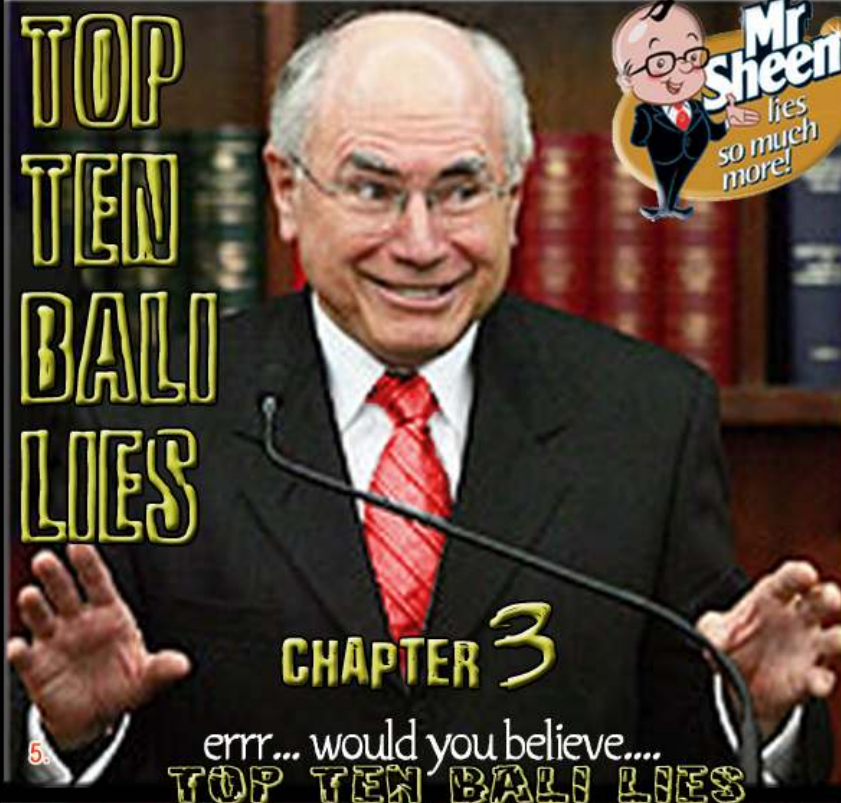

Almost all patients treated with the mysterious "flash" burns never recovered at all.

b) The types of burns we saw at the Bali bombings CAN ONLY be attributed to one or more of the following:

One first responder recalled it as "a carpet of human bodies " on the floor. Pairs of jeans unburned at all peoples hair still intact uninged, yet burn marks of a mysterious nature all over the victims bodies. This was not a diesel-fertiliser bomb people. Is this a new type of nasty?





Just how exactly does one get a 1000 degree INSTANT suntan at 11pm at night at Kuta beach? Its the question that had the Bali doctors stumped, and the Aussie burn experts baffled. This attack had the obvious hallmarks of a micro nuclear warhead with a limited yeild capacity WITHOUT all the messy aftermath of radioactive fallout. Military experts who were familiar with common ordanance scoffed at the suggestion of napalm when the Indo Police suggested it was used. As did doctors. Lie: 1 A fertiliser bomb Used

When comparing car bomb devices sadly a good place to start is the current Iraq situation. The photo below is of a 2005 car bomb in Baghdad was a 4 wheel drive similar to the one reported to have been used by the Bali bombers. This bomb was reported to be 1 ton yeild blast of TNT equivalent. It destroyed 3 cars, killed 2 people and injured 5 near a crowded market place in Tahir Square in the Nations capitol. The crater in the concrete road was estimated to be ".....no bigger than 30 cm...." and though the actual Iraqi street was less crowded than Kutas' Jalan Legian that night, the device definately had little dramatic impact as compared to the Bali device.

The everyday occurance of car bombs and roadside IDE devices can give a clear picture of the destructive forces seen by these indiscriminate devices of terror. We see a "pattern" of injuries in the victims of missing limbs and of metal shrapnel parts lodged into bodies. Fertiliser bombs being the "weapon of choice to Iraqi desert-chicken farmer "insurgents" gives us a basis of reference to draw parallels. If indeed ANY can be drawn. In the bali Bombings the "4 wheel drive" not only survived the one ton device, but the whole engine block remained intact enough for Indonesian Police to "rebuild" it for display. Ask any military explosives guy you might come across, he'll tell you straight. There physically should not be much left of a delivery car exploding this type of car bomb device. It is simply against the law of logic and physics.



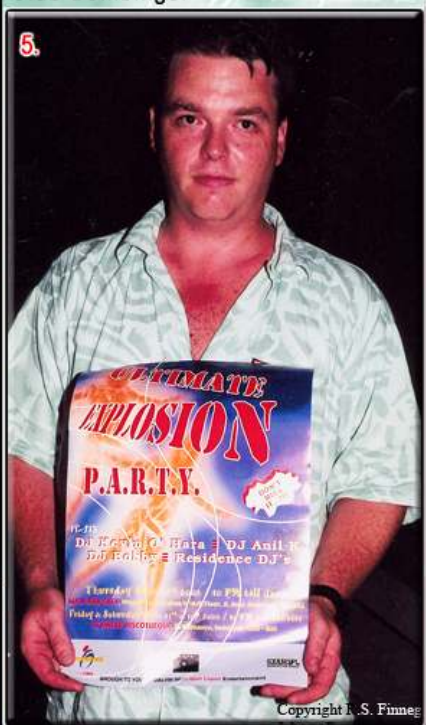

Police Chief Brig. Gen. Budi confirmed the Sari bomb made of RDX military grade explosives.

By now Downer had enough of all these "Conspiracy theories" so he, and the heads of Australia's three intelligence agencies, ASIO, ASIS and ONA, met Indonesia's Security Minister, Susilo Bambang *1. By Sunday Oct. 20 *6 General Pastika says: *"investigation team focusing on four persons, including a security guard and a retired Air Force officer."*

The 7:30 Report the next night in fact was very interesting. On that show that night was Brigadier Edward Aritonang, the deputy chief of investigations with the Indonesian Police. This respected senior Indonesian policeman told the 7:30 Report that traces of more sophisticated chemical explosives may still give a vital lead.

"From the result from the investigation received until now, the materials found on site which was contained in the bomb consist of TNT, LDX, AMX and other forms of chemicals."

The newspapers and more vigorous researchers had recorded a very detailed account of what local people strongly felt and their general consensus on what really occurred: The first theory, which has gained wide currency and not just among conservative Muslims, goes like this: The U.S. embassy issued a warning to its citizens to avoid public places in Indonesia twelve hours before the explosion. Israel Public Affairs Committee) editor of the lobby's newsletter, Near East Report, as well he was also incidently the Washington correspondent for the Jerusalem Post before taking on his high profile role at CNN. Not exactly what I would call "fair and equal" News Reporting background certainly.

So who has ever suggested that this mythical group of invisible boogeymen who plot our destruction have ever played a role in the Bali Bombings?

None other than the "Usual suspects of liars" : George "dubya" Bush, John "dubya" Howard and the US ambassador to Indo. at the time: A one Robert Boyce, they were



speaking about information gained from captured "al Qaeda" agent al-Faruq caught in Indonesia mid-2002, this "info" was used to accuse Bashir, to link Bin-Laden to Bali and used to justify Australian involvement in IRAQ. As we will point out in later chapters, Al-Faruq was a very handy key in selling the Al-Qaeda link lie. Without his supposed "confession" from Gauntanamo, US intelligence agencies would have had ZERO intel to blame Bali Bombings on Al-Qaeda, even Megawati questioned it. The claims and counter-claims Post Bali were flying thick and fast. The truly bizarre aspect of it all was that the Al Faruq arrest had occurred through CIA-and BIN direct negotiations. (BIN is Indonesias Secret Service.) The Indonesian Govt. were not even aware of his supposed "capture" until weeks after it occurred. As it turned out years later, it was revealed that Al Faruq was in fact a CIA agent that had been "placed" in Indonesia to make it appear Al Qaeda were in fact branching out into South East Asia.

In the wake of the October 2002 Bali bombing, a contradictory report emanating from Indonesia's top brass, pointed to the involvement of both the head of Indonesian intelligence General A. M. Hendropriyono as well as the CIA: "The agency and its director, Gen. A. M. Hendropriyono*5, are well regarded by the United States and other governments. But there are still senior intelligence officers here who believe that the C.I.A. was behind the bombing."

In response to these statements, the Bush Administration demanded that President Megawati Sukarnoputri, publicly refute the involvement of the U.S in the attacks. No official retraction was issued. Not only did President Megawati remained silent on this matter, she also accused the US of being: "a superpower that forced the rest of the world to go along with it... We see how ambition to conquer other nations has led to a situation where there is no more peace unless the whole world is complying with the will of the one with the power and strength." *6.

Even the reported links between Jemaah Islamiyaa and Al Qaeda and Bashir were greatly stretching the limits truth. In the "rush" to find someone to blame, the truth became a victim itself.

In fact, both the US and Australian police and intelligence authorities involved in 2002 Bali investigation turned a blind eye on the links between BIN and Jemaah Islamiyaa (JI). BIN was in fact involved in the October 2002 investigation together with its US and Australian counterparts.

This press excerpt shows how determined the Media were in attempting to link all the known "boogeymen" together, in much the same way that BUSH has linked Iraq and Saddam Hussein to Sept. 11th. There are indications, that in addition to its alleged links to Al Qaeda, Jemaah Islamiah also has links to Indonesia's military intelligence, which in turn has links to the CIA*3 and Australian intelligence*4.

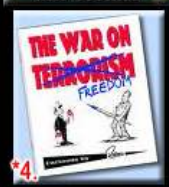
The links between JI and Indonesia's Intelligence Agency (BIN) are acknowledged by the International Crisis Group (ICG): "This link [of JI to the BIN] needs to be explored more fully: it does not necessarily mean that military intelligence was working with JI, but it does raise a question about the extent to which it knew or could have found out more about JI than it has acknowledged."

He drove a late model Audi*2 on campus and was liked by everyone students and teachers alike. "He was a bit of a mad bugger," said John Cooper, an Australian academic at the University of Technology in Malaysia, where Azahari taught.

"He was a guy who could always make people laugh." He had spent four years at school and university in Adelaide. He liked Australia and Australians.

Dr Azahari was indeed a brilliant mathematician with degrees from the University of Technology in Malaysia and Reading University in England*1, from which he graduated in 1990 before returning to UTM as an associate professor. When he was named as a Jamaa Islamiya linked operative this came as more than a surprise it came as a complete shock to those who

knew him personally, something totally out of character for him. In fact, he had come across as a "fun guy" to the students.

"Unlike other lecturers who were all the while wearing kopiah (skullcap*3) and jubah (robe*4), Dr Azahari never once wore such clothes," said Lum, (who in 2005 was) a senior journalist with Oriental Daily.

He said Dr Azahari, who spoke very good English, taught him property valuation, and his lectures were always very interesting.

"Almost the entire class enjoyed his lectures because he used to get us thinking. He explained how to derive the various formulas, unlike others who just gave the formulas," he added.

He said Dr Azahari, who did his doctorate in England, was a jovial man who often talked about the English Premier League.

"He often told us how he used to support the English football teams and there was one occasion when he demonstrated how he used to remove his T-shirt when his team scored a goal.

"If I remember correctly, he was a Manchester United supporter *5," said Lum, who felt sad that such an intelligent man like Dr Azahari had wasted away his life by joining a terrorist network.

Lum said Dr Azahari also used to ride big motorcycles and drive sports cars.

"One of my seniors told me that Dr Azahari owned up to eight motorcycles," he added.

Lum said Dr Azahari, of average build, was also a very fit person as he used to jog and exercise a lot - The Star Malaysian newspaper.

Do you see the picture here? He wasn't a fundamentalist. He was a soccer hoon who did burnouts on fast bikes. Does this sound like a Jamaa Islamiya Fundamentalist "Who blew himself up " rather than be caught.

Shortly after the bombings another bombshell went off on Australian soil. It was revealed firstly in an article in the Washington Post 14th Oct and less than 24 hours later John Howard had to finally admit to the Australian people that "YES" the Govt. did get a warning from the CIA about a threat in Indonesia. "We begin with the stark question about the many dead and wounded in Bali: why weren't they warned?" *L1

The Prime Minister John Howard confirmed in Parliament what readers of the Washington Post*2 had been told more than 24 hours ago. The United States did pass the information onto Australian authorities who analysed it, but concluded there was no need to make it public, or to change formal advice given to Australian travellers.

As a result, while Australians were being warned about continuing violence and instability in Indonesia, they were never warned to avoid or delay travel to Bali.

The Federal Government today admitted that US intelligence did tell Australia of intercepted messages about possible terrorist threats, specifically including mentions of Bali, before October the 12th."

The Guardian*3 notes:

On October 20, 2002 The first body of an Australian victim in the Bali bombing arrived back home yesterday, the coffin draped in the national flag. The remains of Angela Golotta*4, who would have turned 20 this month, arrived at the airport in Adelaide, accompanied by distraught family members. The Australian government has come under heavy criticism over its handling of travel advice surrounding the Bali attack.

Several groups have accused ministers of tailoring information to meet political needs, after Prime Minister John Howard admitted that the government knew of a potential threat to Bali before the attack. *L2

Friday, 22 November, 2002 John Howard very carefully chose his words. "There was

a generalised warning indicating a number of places in Indonesia including Bali *5, but a whole lot of other tourist and cultural spots and that generalised warning was fully consistent with the alerts we already had which the travel advice included references to bombings, to bombs having gone off and the possibility of them going off in the future. But there was nothing specific about Bali, there was nothing in the Intelligence information we had that could have given a clue to this terrible event." *L3

The key word here is "specific" as reporter Catherine McGrath*L1 points out on 16th Oct. 2002: Since yesterday, the Government has used this phrase:

"We had no warning of the specific attack that occurred." The key word here is 'specific'. Certainly the Government wasn't warned that Bali would be attacked on Saturday night, but the United States had identified Bali as a possible target for a terrorist attack." However on 15th May 2004*L4 we learn that Australian Security Intelligence Organisation (ASIO) advised Qantas on July 3, 2002 that "Given the JI [Jemaah Islamiyah] presence in Indonesia, neither Jakarta nor Bali could be considered exempt from attack." Some weeks later, according to Qantas*6 pilots and cabin crew, the company warned them not to use well-known hotels and nightclubs on the island.

Incredible but true. Seems Howard lies again and is caught out again. Even more cracks in the Howard and government's claims began to emerge on May 5 when the ABC*7 reported that Qantas had been summoned to appear before an ongoing Senate committee inquiry into the government's decision not to issue a Bali travel advisory*L4.

Foreign Affairs and Defence Committee members were reportedly concerned that the airline may have pressured the government not to issue a travel warning, following confirmation that Qantas held further discussions with ASIO about the risk of a terror attack on Bali. In its submission to the inquiry ASIO said Qantas had asked the spy agency on July 5, 2002 whether the threat to its interests could be lower in Bali than in Jakarta. ASIO had replied that the general threat to Qantas interests "cannot sensibly be differentiated from the general threat to Australian interests in Indonesia".

Confronted by this evidence, Alexander Downer initially attempted to deny it altogether.

RIGHT UP UNTIL 12TH OCT. 2002, HOWARD GOVT ASSURED AUSTRALIANS BALI WAS SAFE ...DESPITE SEVERAL WARNINGS CONTRARY

On the morning of May 5 he stated that the government was not aware of approaches that Qantas may have made to ASIO about travel advisory warnings. He also asserted that the head of ASIO, Dennis Richardson, had denied that Qantas made any approach. Deny Deny Deny plausible deniability. It wasn't babies overboard anymore, it was truth overboard.

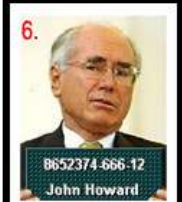
So basically.. as bluntly as wsws.org puts it: "Right up to 12 October 2002, the Howard government assured ordinary Australians it was safe to visit Bali, despite receiving several specific warnings from US intelligence agencies, as well as its own Office of National Assessments (ONA), about likely attacks on the island in response to the US-led assault on Afghanistan.

On the day of the bombing, the Department of Foreign Affairs and Trade (DFAT) travel advice merely cautioned Australians in Indonesia to "maintain a high level of personal security awareness," while

emphasising that tourist services were functioning normally across Indonesia, "including Bali". An Australian Embassy bulletin stated: "Bali is calm and tourist services are operating normally." *L1 While tourists were kept in the dark, intelligence agencies gave the opposite advice to military personnel, diplomats and the management of Qantas, the main airline profiting from travel to Bali. The Australian Security Intelligence Organisation (ASIO) advised Qantas on 3 July 2002 that: "Given the JI [Jemaah Islamiyah] presence in Indonesia, neither Jakarta nor Bali could be

considered exempt from attack." On the basis of reports by ASIO + Defence Intelligence Organisation (DIO),

the Defence Security Agency promulgated a warning on 12 August 2002, upgrading its threat assessment to "high" and insisting that: "All defence members travelling to Indonesia and South East Asia be briefed on the threat." According to media reports, Australian diplomats visiting Indonesia were also instructed to avoid bars and clubs frequented by tourists. Speaking in parliament four days after the Bali bombing, Howard admitted for the first time that the country's intelligence agencies had indeed received prior information that terrorist attacks could occur throughout Indonesia, including Bali. His admission followed a Washington Post report the previous day that the CIA had identified threats to attack a tourist site in Indonesia, mentioning Bali and other locations. Oops looks like we were caught lying Mr Howard. No matter how "specific" you care to claim or how Howard spins it for the media... Some people were warned and some people were allowed to die.

1. Facing mounting public anger, including among Bali victims' families, Howard initially established an inquiry by William Blick, the Inspector General of Intelligence and Security. In his report, selected extracts of which were released last December, Blick acknowledged that a "foreign report" had specified Bali as a possible terrorist target.

2. Nevertheless, he concluded that "there was no intelligence warning of the attack" and the travel advisories issued to tourists were "appropriate".

Blick's report was such a transparent sham that a further inquiry was cobbled together in the Senate on March 24, with the support of Labor, the Australian Democrats and the Greens. Once the Senate's foreign affairs committee called for submissions from the security agencies, it soon emerged that Howard and Blick had covered-up two Bali-specific warnings issued by ONA, which reports directly to the prime minister's office.

3. The first, handed to the government on 27 September 2001, assessed the heightened risks of terrorist retaliation following the invasion of Afghanistan. According to the ONA's submission to the Senate inquiry, the report said there were no signs of

planned attacks on tourist hotels in Bali or Lombok, but "extremists see them as havens of Western decadence". Further, "a tourist hotel in Bali would be an important symbolic target, damaging Indonesia's standing and its debilitated economy". ONA's second warning came in a personal briefing given to Foreign Minister Alexander Downer on June 18 and 19, 2002. In the ONA's words: "Toward the end of the briefing session, in response to a question from Mr Downer about possible targets, Bali, Riau and Singapore were assessed to be attractive targets for Jemaah Islamiyah ... International hotels, nightclubs and airlines/airports were assessed as being high on terrorists' target lists."

4. Then steps in former senior ONA analyst Andrew Wilkie, who resigns from the agency in March to expose the lies being told by the government to justify joining the illegal US-led invasion of Iraq, also revealed that while he was still working for ONA, one of his colleagues had shown him a document warning that Bali was a potential terrorist target.

5. Nevertheless, Howard and his ministers have persisted in claiming that they had no intelligence warning of a possible Bali attack. No minister has been called to appear before the Senate committee, giving the clearest indication that its findings will in no way challenge the government's conduct.

6. Survivors who testified before the Senate inquiry in Adelaide (Sept 03) expressed shock when shown copies of an Australian Security Intelligence Organisation (ASIO) assessment, active since 28 September 2001, classifying Indonesia as a high-level threat to Australians. One after another, they declared they would not have taken

their holidays if they had been made aware of ASIO's warnings. Sturt footballers Julian Burton and Andrew Whiteman said players saw Bali as a safe place to celebrate their grand final victory. "Bali has always been the place where Australians go," he said. "To me the Australian government . . . did not do the right thing." Whether its failure to warn of the dangers of a terrorist attack was the product of gross negligence and contempt for the interests of ordinary citizens or something more sinister Canberra has certainly profited politically from the Bali bombings.

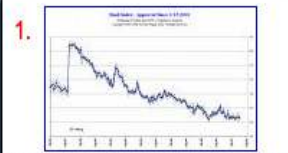
Howard and his ministers immediately seized on the tragedy, declaring that Bali was Australia's own "September 11," to carry through far-reaching shifts in both domestic and foreign policy. In fact there were major parallels with Sept. 11th but for all the wrong reasons:

1. Both the Howard and Bush Govt were warned by Overseas Agencies and Governments prior to both events, about an oncoming terrorist strike, and both the Governments (Despite warning their own In-Party concerns) failed to warn the public appropriately. An extreme act of state negligence, both acts resulting in a loss of innocent citizens of the respective nations.

2. Directly preceding the attack Govt officials blame hitherto little-known Muslim extremist group for attack without little actual physical or circumstantial or ANY credible substantiative evidence. (al Qaeda + Jamaa Islamiyah)

5. The Director of the FBI announces that future terrorist attacks on the U.S. are almost a certainty, just as after Bali, Director-General of ASIO announces that future terrorist attacks on Australians are "certain".

6. In USA the Patriot Act ensures new powers are to be given to FBI and CIA and agencies "to fight terrorism". Just as New powers of detention, arrest on suspicion, forceable random DNA testing were given to State and Federal Police, ASIO and ASIS "to fight terrorism" in Aust.

7. After Sept 11th the USA Govt. initiates TIPS campaign to enlist 20% of the U.S. population to monitor and report on any "suspicious" activities of their fellow citizens. In Australia with the help of actor: Steve Leibman, Howard sets up "terrorist" hotline capable of handling 2000 calls an hour to allow Australians to report "suspicious" activities of their fellow citizens.

8. Directly after the attacks, homes of citizens of muslim faith are suddenly and without warning or provocation are raided by Special Police Units and National Security Agents. In both the US after 9-11 and in Australia after Bali. Approx less than 5% of those detained are actually arrested or even charged with anything. Conversely, After Sept 11 attacks over 200 Israelis were arrested IN CONNECTION with 9-11 but were demanded to be released by Israel!

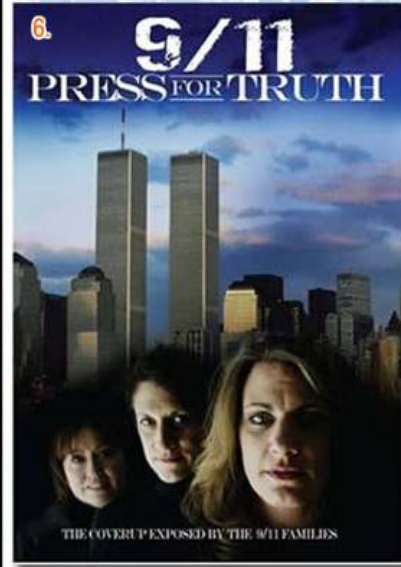

9. U.S. President announces policy of "pre-emptive" attacks against countries "harboring terrorists". Australian Prime Minister announces policy of "pre-emptive" attacks against "terrorists" in S.E.Asia.

10. Both the US President Bush and Aust Prime Minister Howard both continue to ignore pressing questions concerning respective attacks from families of the victims. In the US, 9-11 Press for Truth *6. movie shows the Govt ignoring the largest group of 9-11 families and their questions. Just as Howard ignored Brian Deegan *1. , an Australian whose son Josh was killed in Bali, *2. and other families who pose serious questions about the Govts' Duty of Care failure to warn its citizens.

The Bali blasts were presented as new proof of an "arc of instability" from South East Asia to Fiji, requiring Australian military and political intervention throughout the region. Australian police and intelligence officers were dispatched in force to Indonesia for the first time en-masse onto Indo soil, boosting their ties with the Indo security forces gaining a significant political pointscore for Howard at the same time setting a precedent for police use in other countries. In the 12 months following the Bali bombings Australia has signed counter-terrorism pacts with eight regional countries —Indonesia, Thailand, Malaysia, India, East Timor, Cambodia, Fiji and the Philippines. In the name of fighting terrorism, close ties have been resumed with Indonesia's

notorious Kopassus ^{*1} special forces, an organisation with a record of terror—from the torture and murder of political opponents to systematic violence against entire populations in East Timor, ^{*2} West Papua ^{*3} and Aceh. Most significantly, Howard used the Bali bombing to justify the dispatch of Australian troops to join the Bush administration's criminal and illegal invasion of Iraq, right in the face of the largest anti-war protests in Australian history, he cynically exploited the tragedy to bolster Washington's case for what was a naked US grab for oil and power in the Middle East. Within months, the Howard government's own motives for supporting the invasion and occupation of Iraq became evident. Australian soldiers and police were dispatched to the Solomon Islands, also in the name of combatting the threat of terrorism, to establish colonial-style control over the impoverished country and assert Australian hegemony over the South West Pacific. At home, the government wasted no time in creating a climate of anti-Muslim prejudice launching sweeping attacks on democratic rights under the banner of fighting terrorism.

Within two weeks of the Bali bombing, heavily-armed ASIO officers and the Australian Federal Police carried out violent dawn raids on the homes of Islamic working class families. A new era of state approved terror had reached our shores. At the same time, government ministers stepped up their agitation for the passage of new laws giving ASIO the unprecedented power to detain and interrogate people without trial, simply on the suspicion that they might have information about terrorism. Ultimately, the anti-democratic legislation was passed, with the support of the Labor opposition, eight months later.

Howard has even used the trials of the men charged with carrying out the Bali bombing to try to place the reintroduction of the death penalty back on the agenda. The four main hearings were rushed through the Indonesian courts under draconian anti-terrorism laws, insisted upon by Canberra and Washington, that were then applied retrospectively to the Bali bombing suspects in breach of the constitution. As soon as the first death sentence was announced, Howard, joined by Labor leader Simon Crean, hailed the outcome and deliberately encouraged a public debate over the death penalty in Australia.

With Fear and suspicion rife, in Australian society and people being told to "report everyone suspicious, a stirred up Australian public looking for the al Qaeda Arab "terrorists" were being told our "good aussie sheilas" were being raped by these radical Muslim blokes. BINGO!! Instant recipe for a major race riot at Cronulla beach. ^{*4} Australia had entered an age of racial hatred under Howard. Finally around May 2004, a leaked top-secret document was a letter written to Howard by a former high-ranking Army intel officer Lt Colonel Lance Collins ^{*5} demanding a royal commission into a litany of "poor performance or outright failures" by the intelligence agencies in recent years, including the Bali bombings. This was not the only condemnation Howard faced, even then Opposition leader, Simon Crean said: "I think that the circumstances in which the Americans upgraded their warnings and the Australians didn't is a cause for concern and I think it's appropriate to establish why it was that the Americans upgraded theirs and we didn't." One survivor of the bomb, Robyn Quick, told the Melbourne Age that tourists should have been told of the new warnings. "The govt has got something to answer for."





ABC radio also reported that an ONA analyst had identified Bali as a potential terror target at least three times, including in a briefing to Downer in June before the bombing and at a CIA seminar the previous April.

The ONA officer, David Farmer, stated: "As part of that seminar we had a scenario planning exercise to try and identify where Al Qaeda would be in the future, to build a case for our argument as a scenario we actually used Al Qaeda elements linking up with terrorists in South-East Asia and attacking Bali as a means to describe that particular scenario" IDENTIFIED BALI as a target at least 3 TIMES. Did you get that? In their own working "hypothesis", despite all the evidence, Howard and Downer have always continued, with the help of a compliant media, to maintain that they had no prior warning and bear no responsibility for the Bali tragedy.

Their complete evasions and back-tracking follow a consistent pattern of cover-up. Directly after the Bali bombings when it became known the Australian Government DID IN FACT have prior SPECIFIC knowledge about Sari Club bombings in Bali, John Howard faced a barrage of growing public anger, particularly among victims' friends and families. Then and ONLY THEN did he establish an inquiry by William Blick, the inspector general of Intelligence and Security in Australia at the time.

Even the RAND corporation was scathing of Howards' duplicity in shaping the fateful events: "The Rand Corporation, an influential Pentagon-linked US thinktank, accused ASIO of "blatantly disregarding" threat assessments relating to the Bali bombings. Interviewed on ABC radio, Rand analyst Peter Chalk said ASIO had

apparently failed to act on widely available intelligence about Islamic extremists operating in Indonesia."

On national ABC radio in Jan 03, journalist Matt Brown made the very point that: "ASIO's view that there was a high risk of an attack in Indonesia was explained to the Department of Foreign Affairs more than a year before the attacks in Bali and maintained right up until the blasts. " But these warnings and very "specific" threats were not passed onto the Australian public.

As we will learn soon, even the US knew of the attacks so much so, they began moving their staff and equipment out of Bali the VERY DAY BEFORE the Bali bombings. It seems everyone knew about the impending attacks on Bali except those that needed to know most:

The innocent victims the lively Aussie fellas and sheilas holidaying and just there to enjoy themselves. Obviously according to the Howard govt. these victims were necessary cannon fodder to stifle the Anti-War protests, to silence the war critics, and boost his own poll ratings.

Memos from this period have surfaced from the past CIA desk of George Tenet. *1
 Bush spoke with Tenet who was fully aware of the background of the 9/11 attacks. The CIA and the Mossad have very good, very close relations and the CIA was fully aware of the penetration of the Atta group in Hollywood, Florida and the preparations for the attacks. A discussion was held in Langley between Tenet and a top Mossad *2 official (name withheld at this time) and assurances were given that something certainly can be done to help out here. The resulting attack at Kuta beach was the "Plan B". The initial idea consisted of

placing a certain type of special explosive device (see the "Harring account") in an Australian public building.

Fortunately for the population of Sydney, it failed to go off and is still in place.

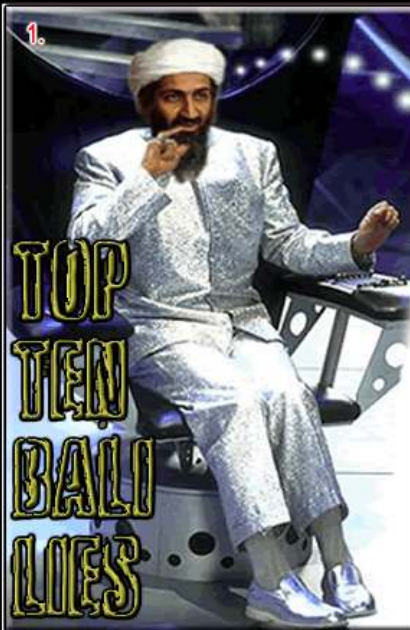

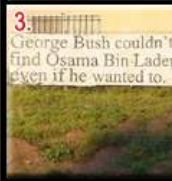

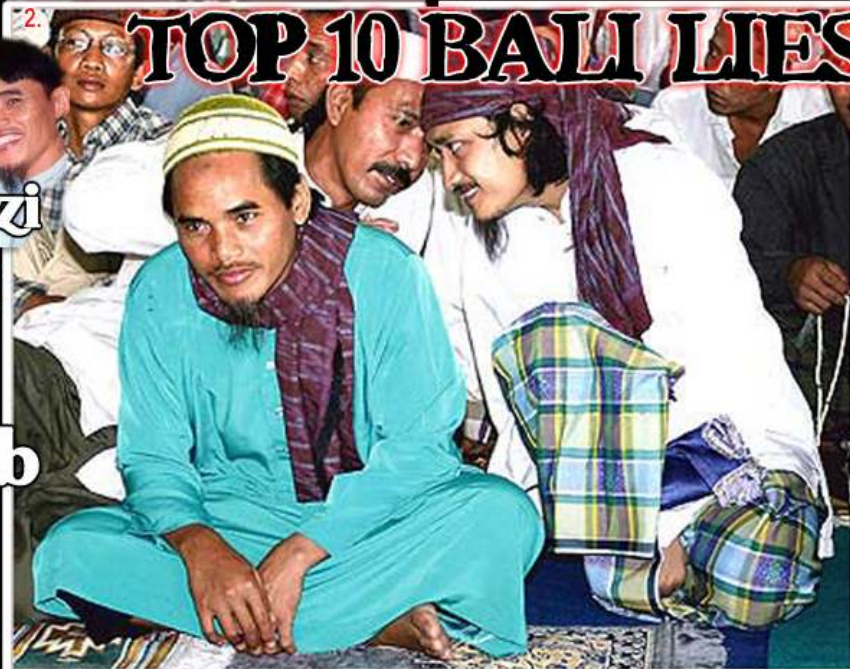

On the official Federal Police website it relates this selection describing the pictures you can see: "Just after 11pm ..Approx. ten to fifteen seconds later, (After Paddys) a second much more powerful car bomb, of close to 1000kg, concealed in a white Mitsubishi van was detonated by remote control in front of the Sari Club. The explosion left a one metres deep crater and windows throughout the town were blown out"..It further states: " The Australian Federal Police (AFP) immediately launched an investigation of the bombings, called Operation Alliance. A team of investigative and forensic officers arrived in Bali within 24 hours after the bomb blasts to assist the Indonesian National Police."

Many eye witnesses refute the 1 mtr deep official version and with valid reason.

Like this account from an interview with survivor Glenn Du Bois:

The blast and fireball tore into both clubs and other surrounding buildings, although it was the Sari Club that took the full force. Those closest to the street near the Sari's entrance, where the wrought-iron fence provided no protection, were among the first to die. A group of Australians and South Africans trying later to rescue people would find a victim near the gate on his hands and knees, "charred rock solid". "I saw the flash and then I woke up, flat on my back, with about five or six bodies on top of me ... from the lower ribcage down," says DuBois. "We'd been standing shoulder to shoulder and it knocked us down like a field of wheat." Remarkable statements from Mr Du Bois. 4.

A Full and comprehensive Forensic analysis was done.

We all know that to ensure a full comprehensive forensic analysis to be undertaken, then exclusivity to a crime scene area ASAP is paramount in establishing tamper free evidence. What the Federal Police forensic team had inherited, was a trampled and contaminated crime scene with already conflicting claims and counter claims about various substances allegedly used in the attacks.

Like most people we are stunned at how quickly, efficiently and speedy and such a "massive scientific task" like Bali forensics were hastily examined, announced and packed up. All neatly wrapped up in one great story. Sold and told to move along, nothing to see here folks.

In a January 3, 2003 Jakarta Post article Editor Robert S. Finnegan wrote: On October 12, 2002 the Indonesian island of Bali experienced a terrorist attack that rocked the world.

It was unquestionably well-coordinated and executed, the largest in the country's history.

Investigators and forensics experts from both national and international teams that had quickly been assembled flocked to the crime scene, ostensibly to begin what should have been a long, drawn out exercise in forensics and investigative sleuthing to identify and capture the foot soldiers, coordinators and master-minds behind the attack that has left over 190 known dead, scores missing without a trace and hundreds more wounded.

It has turned out to be anything but that. The Indonesian government immediately vowed to unite in the hunt for the bombers. The U.S. government along with the international community seized the opportunity to point the finger at the shadowy al-Qaeda group along with Muslim cleric Abu Bakar Ba'asyir as the culprits.





1. A creeping sense of foreboding began soon after the forensics people and other investigators (inclusive of Insp. Gen. I Made Pastika and his army of hundreds of supposedly top-notch investigators with virtually unlimited resources at their disposal) announced after only a week and a half that they were wrapping up their on-site work and retreating to the labs to analyze their findings. Astounding work, as it must have set a world record for crime scene forensic analysis.

Given the scope of the bombing and the sheer size of the primary and secondary blast areas - where trace from a plethora of different explosive compounds were swabbed from - this was a feat that escaped even the vaunted investigators working the World Trade Center crime scene in New York, who spent nearly a year literally sifting by hand for evidence at the site. It would appear that the teams on Bali possessed far superior skills and techniques ... or was there something else responsible for their haste in wrapping up so quickly and then sending the rest of the evidence as quickly as possible to the bottom of the ocean off Bali?

At this point in their investigation National Police Chief Gen. Da'i Bachtiar states for the record that "traces of a chemical powder used in the bomb" were found in the van

allegedly used to transport the large device. What powder? Even a cursory examination of the crater and primary site immediately following the bombings would make this statement laughable were it not for the circumstances. If indeed the Mitsubishi L300 van was used in the large blast, the five-foot deep by twenty-foot wide crater indicates that it would have been completely vaporized, including the engine block which they apparently found intact - along with the victims who instantly vanished.

Indeed, this begs the question: Where did the investigators obtain this evidence in relation to the crater?

Is it possible that if the van survived the large blast it was because it was parked at the edge of the primary blast zone, packed with small amounts of all the explosives - whose traces were found at the sites - in order to throw off independent investigators? In addition, there is the Memorandum of Understanding (MoU), allegedly signed jointly by the National Police and the international investigation team, specifically restricting the scope of the "investigation links" and prohibiting international inquiries. Could this at least partially explain why Pastika has continually stonewalled, intimidated and generally obstructed independent investigators during the course of their work?

During the first weeks of the investigation, notables such as State Intelligence Agency (BIN) Chief Hendropriyono, Susilo Yudhoyono, Assembly Speaker Amien Rais and Pastika focused or pretended to focus on foreigners - without specifying "which" foreigners - who they said were behind the attack.

Somehow this twisting, turning trail dried up and disappeared into thin air without explanation, along with the former retired Air Force Officer who allegedly confessed to police his involvement in the bombing and was then released.



The Bali MEGA Blast

Reinforcing in a concrete structure 50 feet from ground zero stripped clean.

What did this?

Concrete has a yield strength of 3,500 PSI. Amrozi's bomb would only produce 2 PSI to 10 PSI of overpressure.



To this day his whereabouts remain unknown and police investigators either cannot or will not release any information on this man, an officer who was allegedly trained in America in explosives and is an incredible lead that should have been followed-up on aggressively and thoroughly. Why was it not?

Are these the statements and actions of professional investigators - or the actions of individuals engaged in a cover-up?

Let's look at the myriad of explosive traces found at the site and subsequently cited individually off and on by investigators and police as "the explosive" used in the bombings.

First it was C-4, then RDX. These two are actually the same, the difference being nine percent malleable plastic used in C-4. So, which is more powerful? RDX - nine percent more powerful than C-4.

Day after day, investigators trotted out a different explosive and combinations of explosives purportedly responsible for the blasts. In addition to C-4 and RDX there was now TNT, Ammonium Nitrate, HMX, Semtex, PETN, Chlorate and napalm. Everything but the kitchen sink. Was this gross ineptitude? Or another ploy to throw independent investigators off the trail? For example, had the originators of the napalm theory studied up on the material before opening their mouths they would have known that napalm leaves a sticky, smelly residue on everything, including victims.

This was not in evidence at the blast site or at the Sanglah burn ward and morgue, where the burn victims were taken.

Therefore, in the absence of any physical evidence, napalm must be excluded and the originators of this farce be awarded a grade of "F" in "explosives analysis."

In other words, if you are going to lie, be professional about it at least know what you are lying about and have the mental capacity to remember what you said when you said it. This single evidentiary template could easily be applied and extended to the entire "official investigation" of the Bali bombings where deceit, obstruction and obfuscation are and have been the name of the game.

To put this in perspective, let us look at three of the explosives claimed by official investigators to have been used in the bombings, starting with the compound that has the lowest velocity of detonation in feet per second (FPS) which is Potassium Chlorate at 3,500 FPS; compared to 12,000 FPS for Ammonium Nitrate and diesel and finally 27,800 FPS for RDX. In simple terms, at any given distance from ground zero these different explosive compounds will exert pressure in pounds per square inch. Damage to people and structures are a result of this pressure in varying degrees depending on the velocity of detonation. Even if RDX were used, the amount needed to cause the level of

destruction in evidence at the crime scene should have been in excess of anything available through even the military, who denied possession of the explosive. There is also the delivery of the device to be taken into account.





Each of the explosives cited by investigators (with the exception of napalm) have unique and individual characteristics that vary for usage, stability and explosive yield. They require specific detonators for each in order to obtain maximum effect. Also now at the bottom of the ocean off Bali is the reinforcing bar (rebar) located more than fifty feet from ground zero that had been completely stripped of concrete as a result of the blast. Documented military estimates of the force required to accomplish this is roughly 1 million to 1.5 million pounds per square inch.

What kind of weapon or device could accomplish this?

And for that matter leave a crater of that size?

Why was it filled in?

This arguably could have been one of the most important pieces of evidence available to investigators not only for the trace explosive in evidence, but from which also could have been determined (roughly) the size and composition of the device.

With the police claiming (off and on) that Amrozi, Mukhlas and Samudra (who allegedly at one point denied involvement in the Bali bombings) were the perpetrators of the blasts, then why do the official

investigators not know EXACTLY the type of device used in the main bombing and its precise composition?

To put it quite simply, how can we have a bomber or bombers in the absence of a bomb?

Why were Amrozi and Samudra so quick to confess and finger their "accomplices"? Were these the actions of dedicated, radical, Islamic fundamentalists?

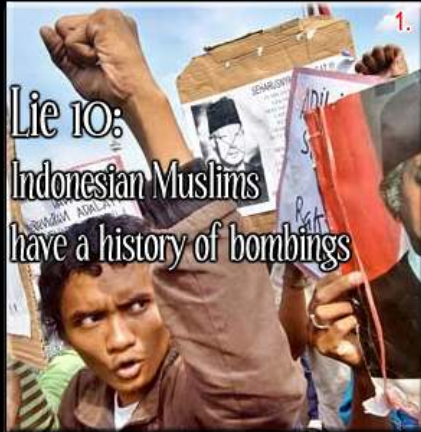
"Professionals"? Did they expect to further their cause by eviscerating their own organization? Does it make sense that they were willing to kill and maim hundreds of innocents - including many fellow Indonesians - and yet implicate their comrades to save their own skins?

Given this dismal investigative performance, exactly what role did the international investigating team play in this debacle? If indeed there is one thing that has been glaringly apparent throughout this investigation, it is that perhaps nothing close to the truth has been told as of today.

It is also apparent that something is very, very wrong not only with the procedural aspects of this case, but also with the suppression and outright destruction of evidence. The international investigators bear a heavy responsibility for this, and should be held accountable."

The bill circumvents a two-year ban on military cooperation between Indonesia and the US put in place following widespread violence by Indonesian-backed militia groups in East Timor in 1999. Both the Indonesian

military and the Bush administration have been pushing for an end to the ban, known as the Leahy amendment, and the reestablishment of close ties.

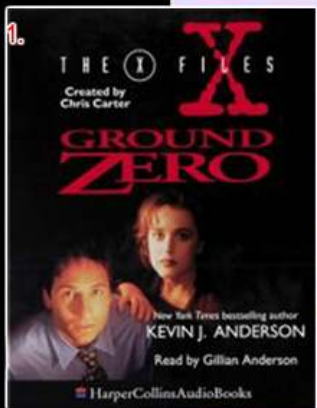

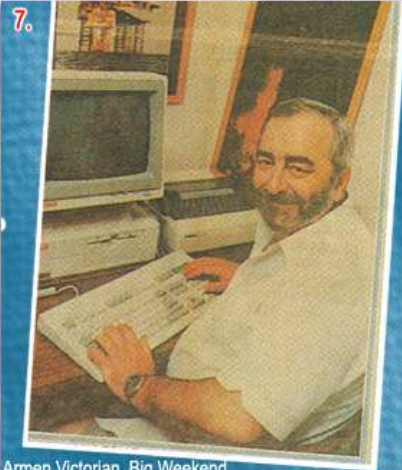
Well so too after Bali there came a movie detailing the Bali Bombers in a highly dramatised version called "Long Road to Heaven."

US ambassador Boyce had been lobbying the Megawati administration and moderate Islamic groups for action to shut down JI, which allegedly has links to other terrorist groups in the region. His overtures, however, have been consistently rebuffed. Jakarta has refused to arrest Bashir, insisting that there is no evidence against him.

One day before Bali, the US threatened to withdraw some of its diplomats unless the police took further steps to investigate a grenade explosion outside an unoccupied US embassy home in Jakarta last month. Senior police officials say that the explosion was not aimed at the US.

Whilst it is certainly possible that JI or other Islamic extremist groups are responsible for the Bali bombing. The US invasion of Afghanistan and its plans for a war against Iraq have provoked widespread hostility in Indonesia and created conditions for such groups to extend their influence. But no conclusive proof has yet been offered. In fact, the broader US allegations against Bashir and the JI rest on "evidence" provided by suspects detained in Singapore, Malaysia and Afghanistan— all held incommunicado and without trial. The chief source is a 31-year-old Kuwaiti, Omar al-Faruq, who was detained by Indonesian police in June, handed over to the US and shipped to Afghanistan where he was interrogated for months by the CIA.

Bashir himself has denied any involvement in the Bali attack and accused the US of being responsible. "It would be impossible for Indonesians to do it," he told a press conference on Sunday. "Indonesians don't have such powerful explosives. I think maybe the US are behind the bombings because they always say Indonesia is part of a terrorist network."

Excerpt Transcript Copied From SBS DATELINE Archives - October 12, 2005

Two weeks after the second Bali attack and despite plenty of help from the Australian Federal Police, Indonesian authorities are still pursuing the culprits. But a familiar pattern has emerged. Asia's most wanted men, the so-called masters of disguise, Dr Azahari and Noordin Top have been named as the masterminds. And once again everyone is insinuating Jemaah Islamiah is behind the bombs. That may eventually be proved correct, but so far no evidence has been produced, at least publicly, to back that claim. As we've shown tonight, after enduring years of state-sponsored terror, it's no wonder many Indonesians question what they're being told about this latest atrocity.

GEORGE ADITJONDRO: You hear again the sources - the statements that it was carried out by Azahari and Noordin Moh Top and a radical Muslim groups behind it. Although what I heard is this actually shows a rivalry, internal rivalry within the armed forces.

George Aditjondro didn't provide any evidence to back his allegation, but theories like this are hard to write off just yet. Former president Abdurrahman Wahid tried in vain to rein the military and it cost him the presidency. In 2003 just after the Marriott Hotel blast, he was clearly frustrated by foreign intelligence claims that JI were to blame.

WAHID: They can say whatever they want but we are here, we live here, we know them. But I won't say who.

REPORTER: But you know who it is, you think?

WAHID: No, no, I don't know. When I said that I meant we cannot know - we cannot

know the truth about that. That is the problem always.

REPORTER: But that bomb has been blamed also on Jemaah Islamiah.

WAHID: Yeah, I know but you don't have any kind of proof. The proof is that the bomb is similar to that belong to the police. It's a problem for us then. Every bomb there until now it belongs to the government. Today is the third anniversary of the first Bali attack that saw 202 people killed, including 88 Australians. Abdurrahman Wahid now has questions about that attack as well. While some regard him as an Eccentric, he is the former president and is often described as the conscience of the nation, revered by tens of millions of moderate Muslims. As such, he's one of only a few people publicly prepared to canvass the unthinkable - that Indonesian authorities may have had a hand in the Bali atrocity. He believes that the plan for the second, massive at the Sari Club, which caused the majority of casualties, was hatched way above the head of uneducated villagers like Amrozi.

WAHID: Amrozi was involved in the lighter bomb. That's a problem always. Even though I agree that he should be given a stiff punishment, but it doesn't mean that he is involved. No, no, no.

REPORTER: So you believe that the Bali bombers had no idea that there was a second bomb?

WAHID: Yeah, precisely.

REPORTER: And who would you suggest planted the second bomb?

WAHID: Well, it looks like the police.

REPORTER: The police?

WAHID: Or the armed forces, I don't know.

Wahid's speculation is chilling and again there's no evidence to support it. But there's no doubt that he's a barometer of how many Indonesians view the whole terror campaign.

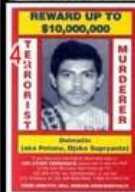

Amrozi bin Nurhasyim was born in 1962 in the sleepy village of Tenggulun, a few miles inland from the coast of East Java, the fifth of 13 children . Been described as something of a black sheep, Amrozi did not do well at school, appearing more interested in motorbikes and girls.



After the Bali Blasts, his mother, Haji Tariyem, told the BBC 6. that Amrozi was a good boy, who at the time of the Bali attacks was living at home looking after his sick father.

Villagers in Tenggulun have said that Amrozi left for Malaysia in the late 1980s in search of work, and returned in 1991 with much stronger Islamic beliefs.

While in Malaysia, police said he was reunited with his elder brother, Mukhlas, a deeply religious man and also on trial for the Bali attack. Amrozi has described Mukhlas as an inspiration to him.

Police said that when Mukhlas returned to Tenggulun, he became more involved in the village's Al Islam boarding school, founded by another of Amrozi's brothers, where about 150 students follow a strictly religious curriculum.

Amrozi is said to have admitted to meeting the Muslim preacher Abu Bakar Ba'asyir on several occasions - while Mr Ba'asyir was in exile in Malaysia in the 1990s and more recently after the preacher's return in 1998, when he was invited to speak at the Al Islam school.

Amrozi angered families of the Bali bombing victims when he was paraded before the media in November waving and laughing, and was quoted as saying that he was "delighted" by the attack.

"There is no regret at all for him. Doing his duty to God, he shows no regret. He's very calm, very cool... proud of his activities," the chief of the investigation, General I Made Mangku Pastika has said. Mr Pastika said Amrozi's only regret about the bombing was the fact that most of the dead were Australians rather than Americans.

"He doesn't regret it but he is just unhappy," Mr Pastika added.

Captured little more than a month after the October 12 blasts in Bali, Amrozi was quick to confess he had bought the minivan used in the main car bomb attack and the chemicals to make the explosives. Shortly after his arrest, the first of 34 people held in connection with the bombing, he was paraded before invited journalists where he was photographed laughing and joking with his police captors.

He told them he was proud of what he had done, saying the attack was designed to kill as many Americans as possible and he was disappointed that most of the dead were Australians.

That provoked further astonishment. Bali is widely known as a popular and cheap holiday destination for thousands of young Australians and any attack there was bound to cause a large number of Australian casualties.

His statement was a sign of Amrozi's low educational level and an early indicator that he was in no way the brains behind the operation.

Rather Amrozi appears to have been an easily impressionable and enthusiastic operative in a ruthlessly planned attack designed simply to cause a maximum number of casualties.

His lawyers based his defense around proving he was not one of the planners of the carnage.



But still questions remain over how a once shy mechanic from a small village in eastern Java became the face of one of the worst terrorist attacks in recent years. Amrozi has, however, denied being a member of JI, saying he carried out the attacks to avenge the repression of Muslims around the world.

"Whites" he told the judges during his trial, deserved to die. "Violence is the only language they understand."

Amrozi would later retract these statements saying much of the confessions he signed were done so under physical Police torture and intensive interrogation. Although he has been sentenced to death, the actual sentence has yet to be carried out. A brutal mastermind? Or a simple patsy standing on trial for a crime much bigger than his own?





Name: Imam Samudra (real name Abdul Aziz bin Sihabudin; also known as "Fathi", "Kudama", "Hendri", "Alfatih" and "Heri")

Date of Birth: 14 January, 1970

Engineer and computer expert.
Seasoned Jemaah Islamiyah operative. Attended Lukmanul Hakim school, Muklas' militant Islamic college in Johor. Idris attended the same school. Went on to run his own military training camps.

Allegedly: Spent 1993-1996 in Afghanistan with the Mujiheddin. Lived in Malaysia 90-2000 where he met Abu Bakar Bashir, Muklas and Ali Imron.

Was responsible for the idea of hitting Bali and in his confession lists 13 reasons for choosing the popular holiday spot. Set up a website after the bombing to explain the attack to Muslims. Was field commander for the bombing in Bali, responsible for "ideas, Islamic law and strategy". Chose the targets, recruited the foot soldiers and allocated the tasks. Also ordered the robbery of the Elita Gold Shop in Serang which provided some of the funding for the operation in Bali.

Status:
Arrested November 21, 2002 trying to escape to Malaysia.

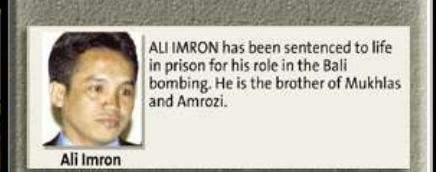

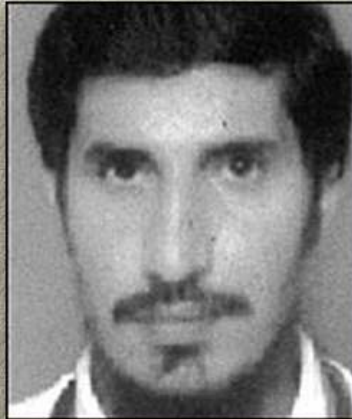

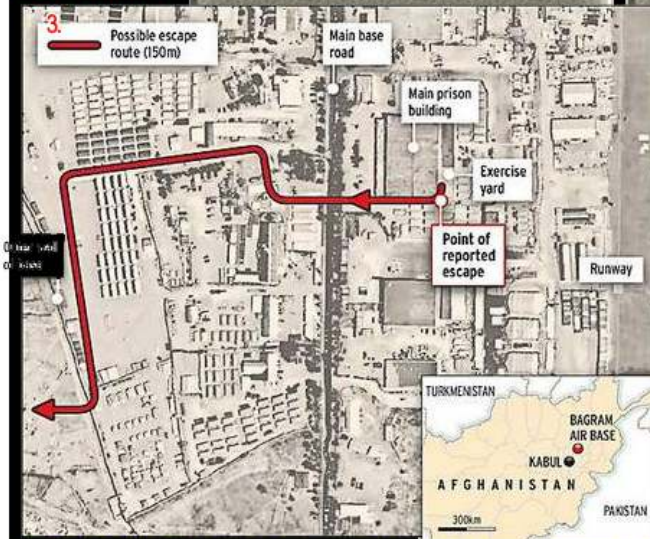
